BUSINESS ARISING

1. CONTRAVENTION OF BYLAW 4:4 Allowable Pets Within Suites

Owner of #305 has rented suite to tenant with a dog, which contravenes our Bylaw on p.3: 4: (4) An owner, tenant or occupant must not keep any pets on a strata lot other than one or more of the following:(a) a reasonable number of fish or other small aquarium animals;(b) a reasonable number of small caged animals;(c) up to 2 caged birds;(d) a reasonable number of cats. (Amended by Special Meeting 2 October 2001). Strata Council had discussion with HVD, owner Suite #305, at Strata Council meeting Nov 26. General Discussion today about issue. **Decision:** Strata Council to send owner letter/email of Fine, to start December 15, 2022, until owner in compliance with Bylaw. (1st, 2nd CARRIED)

2. ELECTRICAL UPGRADE

Electrical contractor expects Main Switch Panel, which is being fabricated, to be ready in two weeks. Discussion: Can we rent generator for temporary power? Yes. Contractor wants to do work on a Friday, which could have power outage go until Saturday, if there are delays. And "Power up" requires BC Hydro, who don't work Saturday. **Decision:** TH/JP to tell contractor job needs to be done on a Thursday/Friday, so that BC Hydro available. (1st, 2nd CARRIED)

3. MORE ELECTRICAL

Contractor wants to change the main service runs from copper to aluminum, allowed under code: cheaper for us and more flexible to work with. Discussion: we had specified copper. **Decision:** TH/JP to tell contractor we want copper. (1st, 2nd CARRIED)

Contractor wants to change out our original metal weather head to PVC. Discussion: Important not to disrupt/damage stucco wall. **Decision:** TH to tell contractor he can use PVC, but must not damage wall. (1st, 2nd CARRIED)
